Conservative Fund Canada only accepts personal pre-authorized debits (PADs). Please note that contributions from corporations, labour unions or associations, and unincorporated associations are prohibited. You may cancel or change your monthly contribution at any time by calling the Conservative Party of Canada at 1-866-808-8407 or by notifying the Party in writing at Suite 1720-130 Albert St., Ottawa, ON K1P 5G4. You have certain recourse rights if any debit does not comply with this agreement. For example, you have the right to receive reimbursement for any debit that is not authorized or is not consistent with this PAD Agreement. Political Tax Credit and Receipt Information

Contributions may qualify you for a tax credit on your federal income tax return as illustrated below.

In accordance with the Conservative Government's Federal Accountability Act, the Conservative Fund Canada, on behalf of the Conservative Party of Canada, accepts contributions from individual Canadian citizens or permanent residents to a maximum of \$1625 per calendar year.

Tax receipts can only be issued in the name of the contributor and the contributor is considered to be the holder of the credit card or the signatory on the cheque. Please note that contributions from corporation, labour unions or associations, and unincorporated associations are prohibited.

Canadian citizens or permanent residents may also donate a separate amount up to \$1625 to a combination of Conservative riding associations, candidates and nomination contestants, in addition to contributions made to the National Party.



PLEASE NOTE: Payment by cash, corporate cheque or corporate credit card is not permitted. Membership fees are non-refundable and non-receiptable in accordance with Canada Revenue Agency Guidelines.
